LCC is committed to providing accessible Early Childhood Education to ALL.

The Daily Tuition Rate for the 2024/2025 School Year is \$63/day. This includes programming from 8:00am - 3:30pm, breakfast snack, lunch and afternoon snack.

The Extended Day Care Rate for the 2024/2025 School Year is \$10/day. This includes care from 3:30pm - 4:30pm. Availability and rate is subject to change depending on participation of at least 6 children.

A 5% sibiling discount is offered if children are enrolled together in the same year. The discount is applied to the oldest child's tuition.

The Leelanau Children's Center uses an early childhood education management software called BRIGHTWHEEL. After submitting registration forms, parent(s) will be emailed a Brightwheel invitation to sign up to manage their child(ren)'s account.

Tuition + Extended Day Care will be billed in nine, equal monthly invoices Sept 2024 - May 2025.

The Leelanau Children's Center requires all families to pay for their registration and monthly invoices through Brightwheel. Families are required to register a payment method with Brightwheel at least one week prior to the first day of school. Invoices will be emailed 7 days prior to due date. Multiple parents/family members may register a form a payment via Brightwheel. Invoices may be split between parents/family members upon request. Should a refund be necessary, the original form of payment used will be credited. Any billing concerns must be brought to the attention of the Program Director within 30 days of the billing date, or the original billing will be considered correct. Past due (30 days of non-payment is considered past due) accounts will be assessed a late fee of \$10 per month.

The Great Start Readiness Program (GSRP)



The GSRP is a State of Michigan funded preschool program available for qualifying children who are four years old by December 1st, 2024. If you are interested in receiving more information on this program, please let our Program Director know. All four year old children whose family is at or below 300% of the federal poverty level will qualify automatically (find Federal Poverty Level calculator online). LCC can also apply for a limited number of over-income slots.
